BYLAW NO. 2236, 2018

A BYLAW TO DEDICATE COLLETT ISLAND NATURE SANCTUARY

WHEREAS pursuant to Section 30 of the *Community Charter*, a council of a municipality may by bylaw adopted by 2/3 of all members of council, dedicate municipal land for municipal park purposes;

AND WHEREAS the City of Merritt owns municipal lands legally described in Schedule "A" and depicted in heavy red outline on the plan attached as Schedule "B" (the "Lands"), which Schedules form part of this Bylaw;

The Municipal Council of the City of Merritt, in open meeting assembled, enacts as follows:

- 1. The Lands are hereby dedicated as park, for the purposes of biodiversity conservation.
- 2. The park shall be named the Collett Island Nature Sanctuary.
- **3.** This Bylaw may be cited as the "Collett Island Nature Sanctuary Dedication Bylaw No. 2236, 2018".
