

CITY OF MERRITT BYLAW NO. 2140

A BYLAW TO EXEMPT CERTAIN PROPERTIES FROM TAXATION FOR THE CALENDAR YEAR 2013

The Council of the City of Merritt in open meeting assembled enacts as follows:

1. That this bylaw may be cited as “**CITY OF MERRITT TAX EXEMPTION BYLAW NO. 2140, 2013**”.

2. That pursuant to Section 224.2(j) of the *Community Charter (SBC Ch.26)* the following property is exempt from taxation for the calendar year 2013, land described as;

Lot A, Plan KAP77597, D.L.125, K.D.Y.D., and the buildings and structures thereon (Nicola Valley Association for Community Living aka Ska-Lu-La Workshop);

3. That pursuant to Section 224.2(i) of the *Community Charter (SBC Ch.26)* the following property is exempt from taxation for the calendar year 2013, land described as;

Lot 2, Plan 22544, D.L. 124, K.D.Y.D., and the buildings and structures thereon (Merritt Curling Club);

Parcel A, D.L. 124, K.D.Y.D., except Plan 33125 and the buildings and structures thereon (Merritt Golf and Country Club);

Lot 2, Plan 29664, D.L. 174, K.D.Y.D., and the buildings and structures thereon (Merritt Golf and Country Club);

Lot 1, Plan 8212, D.L. 174, K.D.Y.D., except M9110, excluding Mobile Home, and the buildings and structures thereon (Merritt Golf and Country Club);

Lot A, Plan 34206, D.L. 124 K.D.Y.D & D.L. 180 and 181, and the buildings and structures thereon (Merritt Golf and Country Club);

PLAN M9110, D.L. 174, K.D.Y.D. except Plan 19948 and 29664, K.D.Y.D., and the buildings and structures thereon (Merritt Golf and Country Club);

Lot A, Plan 34260, D.L. 176, K.D.Y.D. (except Mobile Home) and the buildings and structures thereon (Nicola Valley Memorial Rodeo Association Property and Nicola Valley Fall Fair Association - Rodeo Grounds).

4. That pursuant to Section 224.2(k) of the *Community Charter (SBC Ch.26)* the following property is exempt from taxation for the calendar year 2013, land described as;

Lots 1-4, Block 24, Plan 1, D.L. 125, K.D.Y.D., PART N OF PLAN 400 & LOT A, PLAN 1221, D.L. 125, K.D.Y.D., and the buildings and structures thereon (Nicola Valley Senior Housing Society)

5. That pursuant to Section 224.2(a) of the *Community Charter (SBC Ch.26)* the following property is exempt from taxation for the calendar year 2013, land described as;

Lot A, Plan KAP60947, D.L. 125, K.D.Y.D. and the buildings and structures thereon (Royal Canadian Legion)

Lots 1 and 2, Plan KAP62405, Section 22, Township 91, K.D.Y.D. (Nicola Valley Health Care Endowment Foundation)

Lot B, Plan 332, D.L. 125, K.D.Y.D. except Plan 6875 and the buildings and structures thereon (Nicola Valley Research Society)

Lot 1, Block 1, Plan 838, D.L. 125, K.D.Y.D. (Nicola Valley Holding Assn dba Elk's Merritt Lodge #441)

Lot AM1, Block 4, Plan 838, D.L. 125, K.D.Y.D and the buildings and structures thereon (Nicola Valley Holding Assn dba Elk's Merritt Lodge #441)

Lot 3, Plan KAP58641, D.L. 121, K.D.Y.D. (Nicola Native Lodge Society)

Lot 11, Block 17, Plan 1, Part S1/2, D.L. 123, K.D.Y.D and the buildings and structures thereon (Nicola Valley Health Care Auxiliary)

Lot 17, Block 15, Plan 1, D.L. 125, K.D.Y.D and the buildings and structures thereon (Merritt Walk of Stars Society)

Lot 1, Plan 41762, D.L. 123, K.D.Y.D. and the buildings and structures thereon (Conayt Friendship Society)
