BYLAW NO.1539

A BYLAW TO ESTABLISH A SPECIFIED AREA FOR THE PURPOSE OF PROVIDING WATER SERVICES TO AN AREA WITHIN THE CITY OF MERRITT AND TO AUTHORIZE THE BORROWING OF FUNDS NECESSARY THERETO.

WHEREAS, Division (2) of Part 16 of the Municipal Act being Chapter 290, R.S.B.C., 1979 and all amendments thereto, provides Council with the authority to establish areas for the financing of works therefore;

AND WHEREAS, it is deemed expedient to install water service, installed to permit development within an area of the City of Merritt;

AND WHEREAS, notice of the intention of the Council to undertake the construction, pursuant to Section 656 of the Municipal Act, of the work hereinafter described has been duly given by publication of notice and by service of it upon the owners of the parcels liable to be specially charged and the publication of such notice has been proved by a statutory declaration filed by the Clerk and no petition against the work, signed by a majority of the owners representing at least one-half of the value of the parcels which are liable to be specially charged, has been presented;

AND WHEREAS, the cost for such works is estimated to be two million, sixty thousand Dollars (\$2,060,000.00) which is the amount of debt intended to be created by this bylaw;


AND WHEREAS, financing of the proposal may be carried out through the Municipal Finance Authority of British Columbia;

AND WHEREAS, the amount of the assessed value for the municipality for general municipal purposes of the taxable land and improvements for the current year and for each of the two (2) years immediately preceding the current year were:

\$252,106,148.00(1994)
\$199,979,348.00(1993)

AND WHEREAS the value at the 31st day of December 1994 of the utility systems and other municipal enterprises was \$5,364,026.00 (1994);

AND WHEREAS the amount of the authorized and issued debenture debt of the municipality is \$2,189,099.00 and none of the principle or interest of the debenture debt of the Municipality is in arrears;

AND WHEREAS the maximum term for which debenture may be issued to secure the debt created by this bylaw is fifteen (15) years.

NOW THEREFORE the Council of the City of Merritt in open meeting assembled enacts as follows:

1. This Bylaw shall be cited as **"CITY OF MERRITT WATER SPECIFIED AREA (COLLETTVILLE) ESTABLISHMENT AND LOAN AUTHORIZATION BYLAW NO. 1539, 1996."**
2. The Council of the City of Merritt is hereby empowered and authorized:
 - (a) to establish a specified area hereinafter referred to as the "City of Merritt Water Specified Area (Collettsville)", and such area shall comprise of that tract of land more particularly described in Schedule "A" and outlined on Schedule "B", which are attached to and forming part of this bylaw;
 - (b) to undertake and carry out or cause to be carried out works in accordance with plans on file in the office of the municipality and to do all things necessary in connection therewith and without limiting the generality of the foregoing;

2. (c) to borrow upon the credit of the Municipality a sum not exceeding two million sixty thousand dollars (\$2,060,000.00) and in connection therewith to enter into an agreement with the Municipal Finance Authority of British Columbia for the term financing of all or a portion of such sum;
- (d) to acquire all such easements, rights-of-way, licenses, rights, or authorities as may be requisite or desirable for or in connection with the construction of said works.
3. The cost of providing the works shall be borne by the owners of the land in the said specified area, and a sum sufficient therefore shall be recovered for such period of time as is necessary by the imposition of a frontage tax to be imposed by bylaw.
4. Should the sums recovered through the levy of the frontage tax at any time be insufficient to meet the costs of the repayment of the debt, the Council may levy and impose within the specified area, a rate on land and improvements over and above all other rates sufficient to meet such deficit in the same manner and time as other general municipal levies.
5. Any owner whose parcel is subject to being specially charged under Section 3 may commute, on a one-time basis only, for payment in cash the special charges imposed thereon, by paying the portion of the cost of construction assessed upon such a parcel, within thirty (30) days of receipt of written instructions from the Collector.
6. The specified area established by this bylaw may be merged with any other specific area or areas for the same purpose, whether contiguous or not, in the manner provided in Section 677(3) of the Municipal Act.

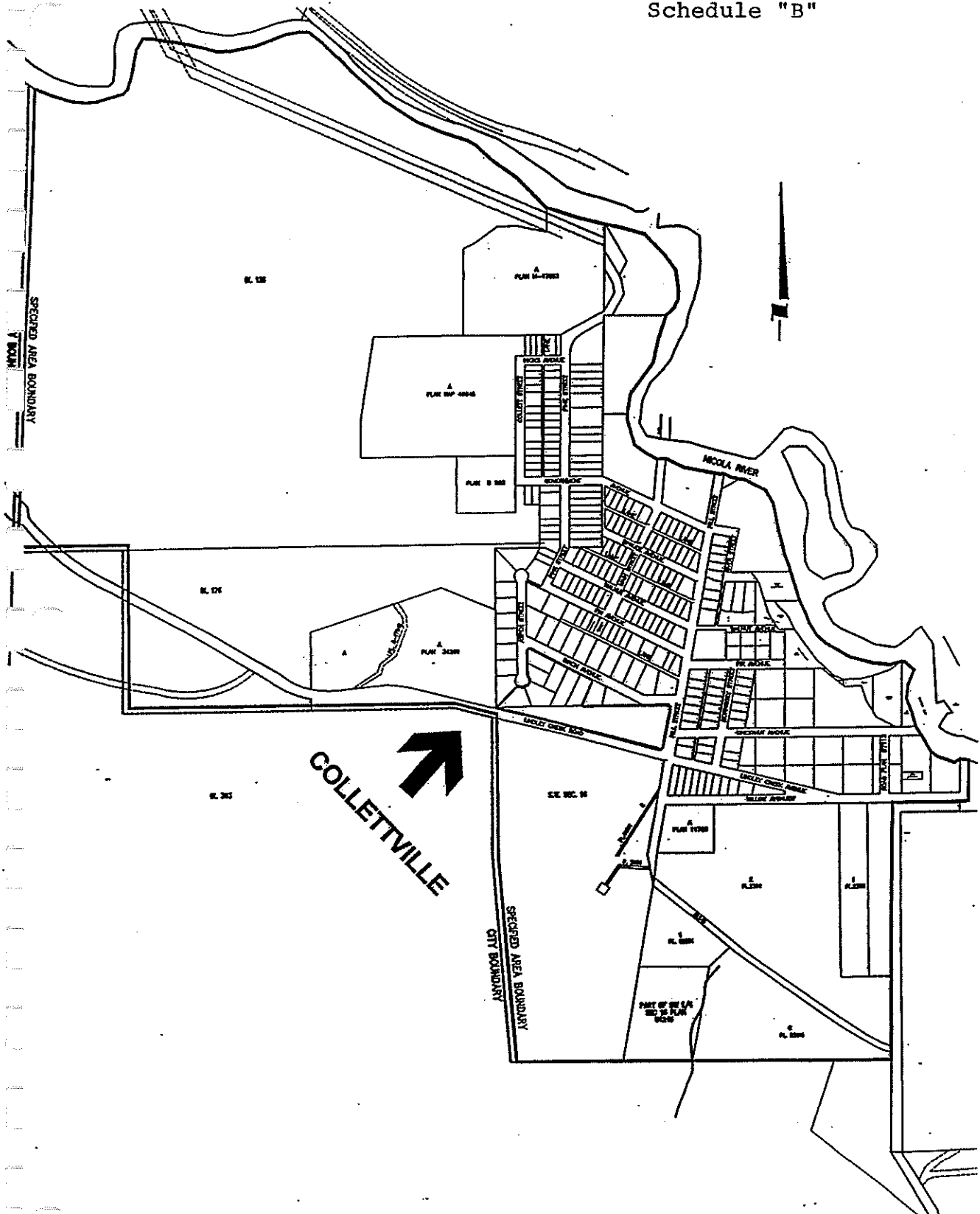

A BYLAW TO ESTABLISH A SPECIFIED AREA FOR THE PURPOSE OF PROVIDING SANITARY SEWER SERVICES TO AN AREA WITHIN THE CITY OF MERRITT AND TO AUTHORIZE THE BORROWING OF FUNDS NECESSARY THERETO.

WHEREAS, Division (2) of Part 16 of the Municipal Act being Chapter 290, R.S.B.C., 1979 and all amendments thereto, provides Council with the authority to establish areas for the financing of works therefore;

AND WHEREAS, it is deemed expedient to install sanitary sewer service, installed to permit development within an area of the City of Merritt;

AND WHEREAS, notice of the intention of the Council to undertake the construction pursuant to Section 656 of the Municipal Act, of the work hereinafter described has been duly given by publication of notice and by service of it upon the owners of the parcels liable to be specially charged and the publication of such notice has been proved by a statutory declaration filed by the Clerk and no petition against the work, signed by a majority of the owners representing at least one-half of the value of the parcels which are liable to be specially charged, has been presented;

AND WHEREAS, the cost for such works is estimated to be two million, nine hundred seventy-five thousand dollars (\$2,975,000.00) which is the amount of debt intended to be created by this bylaw;

AND WHEREAS, financing of the proposal may be carried out through the Municipal Finance Authority of British Columbia;

AND WHEREAS the amount of the assessed value for the municipality for general municipal purposes of the taxable land and improvements for the current year and for each of the two (2) years immediately preceding the current year were:

\$252,106,148.00 (1994)

\$199,979,348.00 (1993)

AND WHEREAS the value at the 31st day of December 1994 of utility systems and other municipal enterprises was \$ 5,364,026.00(1994).

AND WHEREAS the amount of the authorized and issued debenture debt of the municipality is \$2,189,099.00 and none of the principle or interest of the debenture debt of the Municipality is in arrears;

AND WHEREAS the maximum term for which debenture may be issued to secure the debt created by this bylaw is fifteen (15) years.

NOW THEREFORE the Council of the City of Merritt in open meeting assembled enacts as follows:

1. This bylaw shall be cited as **"CITY OF MERRITT SANITARY SEWER SPECIFIED AREA (COLLETTVILLE) ESTABLISHMENT AND LOAN AUTHORIZATION BYLAW NO.1540 , 1996"**
2. The Council of the City of Merritt is hereby empowered and authorized:
 - (a) to establish a specified area hereinafter referred to as the "City of Merritt Sanitary Sewer Specified Area (Collettsville)", and such area shall comprise of that tract of land more particularly described in Schedule "A" and outlined in Schedule "B", which are attached to and forming part of this bylaw;
 - (b) to undertake and carry out or cause to be carried out, works in accordance with plans on file in the office of the municipality and to do all things necessary in connection therewith and without limiting the generality of the foregoing;

2. - Cont'd.

2. (c) to borrow upon the credit of the Municipality a sum not exceeding two million nine hundred and seventy-five thousand dollars (\$2,975,000.00) and in connection therewith to enter into an agreement with the Municipal Finance Authority of British Columbia for the term financing of all or a portion of such sum;
- (d) to acquire all such easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for or in connection with the construction of said works.
3. The cost of providing the works shall be borne by the owners of the land in the said specified area, and a sum sufficient therefore shall be recovered for such period of time as is necessary, by the imposition of a frontage tax to be imposed by bylaw.
4. Should the sums recovered through the levy of the frontage tax at any time be insufficient to meet the costs of the repayment of the debt, the Council may levy and impose within the specified area, a rate on land and improvements over and above all other rates sufficient to meet such deficit in the same manner and time as other general municipal levies.
5. Any owner whose parcel is subject to being specially charged under Section 3. may commute, on a one-time basis only, for payment in cash the special charges imposed thereon, by paying the portion of the cost of construction assessed upon such a parcel, within thirty (30) days of receipt of written instructions from the Collector.
6. The specified area established by this bylaw may be merged with any other specified area or areas for the same purpose, whether contiguous or not, in the manner provided in Section 677(3) of the Municipal Act.
